#### Is Alstom a good company?

Alstom is a global leader in the world of power generation, power transmission and rail infrastructure and sets the benchmark for innovative and environmentally friendly technologies. The Group employs 93,000 people in 100 countries and had sales of à¢âEUR?¬20.3 billion in 2012/13.

#### Will Alstom buy Bombardier?

The deal required the approval by Alstom shareholders at a meeting to be held in October 2020 and approval by European regulators. Bombardier's major shareholder, Caisse de dépôt et placement du Québec,had already agreed to the sale. In July 2020, it was announced that the EU competition authorities had approved the purchase.

#### Is Alstom still a popular power source?

While the coal power market,in which Alstom still packs significant punch when compared with the decline it has experienced in its gas turbine operations, is under threat from the shift towards more environmentally friendly fuel sources, it remains a popular power source, particularly in emerging markets.

#### Will GE buy Alstom?

Siemens is the second largest player in the gas turbine market behind GE. While GE dominates its domestic market, Siemens has a far larger share of the European market. The acquisition of Alstom by GE could significantly shift that balance of power. The US Environmental Protection Agency has been accused of 'waging a war' on coal.

#### What happened to Alstom & Bombardier?

To finish the deal, Alstom had to sellthe Alstom DDF factory based in France, a regional train division, a Bombardier facility in Germany, and a Bombardier trains division. The company also had to provide guarantees and pass on some of Bombardier's assets.

In 2014, General Electric (GE) announced that it reached a deal to purchase Alstom's power and grid divisions for US\$17 billion (EUR12.4 billion). The deal came under heavy scrutiny from French regulators who saw the business as a strategically important domestic industry.
