#### Did SolarEdge buy SMRE?

In January 2019 SolarEdge announced the acquisition of a majority stake in SMRE- an Italian EV powertrain manufacturer. In 2019 SolarEdge announced the acquisition of Gamatronic, a UPS manufacturer, and established its Critical Power division

When did SolarEdge start production?

The company started mass production of its products by contract manufacturer Flex at the end of 2009. In March 2015,SolarEdge had an initial public offering of 7,000,000 shares of its common stock at a price to the public of \$18.00 per share,raising \$126 million.
