When will the US start investigating crystalline silicon photovoltaic cells?

The U.S. Department of Commerce is expected to begin investigations on May 14, 2024. On April 24, 2024, antidumping duty (AD) and countervailing duty (CVD) petitions were filed on crystalline silicon photovoltaic cells, whether or not assembled into modules, from Cambodia, Malaysia, Thailand and Vietnam.

Are crystalline silicon photovoltaic cells antidumping or countervailing duty?

The American Alliance for Solar Manufacturing Trade Committee filed both antidumping duty petitions and countervailing duty petitions on crystalline silicon photovoltaic cells, whether or not assembled into modules, from Cambodia, Malaysia, Thailand and Vietnam.

How does the ITC determine if solar cells are subsidized?

The ITC will determine whether the domestic solar cell and module industry is suffering material economic injury by reason of subject imports. Commerce will determine whether, and if so, to what extent, the imports are being dumped and/or subsidized. The antidumping duty margins alleged for each country are listed below:

When will the ITC determine if a solar cell import is dangerous?

The ITC will preliminarily determine, within 45 days after the date on which the Petitions were filed, whether there is a reasonable indication that imports of solar cells from Cambodia, Malaysia, Thailand, and/or Vietnam are materially injuring, or threatening material injury to, a U.S. industry.
