How do I use the Customs Info database?

To use the Customs Info Database, you will need the Harmonized System (HS) code for your product. An easy way to find your HS code is by using the US Census Bureau's Schedule B Search Engine. The engine will ultimately guide you to a complete, 10-digit Schedule B number for your exports.

How do I find the tariff code for a product?

Use our simple and easy to use HS (Harmonized System) and HTS (Harmonized Tariff Schedule) code lookup tool to find the tariff code for products that you plan on importing into the U.S. 1. Start by entering the name or description of the product being imported. You can also search using a full or partial HS code, if you have it. 2.

Do I need a Schedule B number to export a product?

You will needthe U.S. Schedule B number for your product when exporting out of the United States. The first 6 digits will contain the Harmonized System code. You can use this information to: Report shipments in the Automated Export System (AES) when the value is more than \$2,500,or the item requires a license.
