How much did Honeywell buy CAES systems?

CHARLOTTE, N.C., Sept. 4, 2024 /PRNewswire/ -- Honeywell (NASDAQ: HON) today announced the completion of its acquisition of CAES Systems Holdings LLC (CAES) from private equity firm Advent International for approximately \$1.9 billion in an all-cash transaction.

Who is CAES holdings?

CAES Holdings is one of the businesses created by Advent International when it acquired UK-based defence company Cobham in 2020 in a £4bn (\$5.6bn) takeover. At the time, Advent expressed its "long term commitment to investing in the UK" through the deal.

Where is CAES based?

Headquartered in Arlington, Va., CAES (formerly known as Cobham Advanced Electronic Solutions) has 13 facilities in North America, including highly automated manufacturing facilities with fully automated test and tuning processes. The acquisition will add approximately 2,200 employees and a deep bench of RF engineering talent.
