What if EHL hadn't funded enerox?

If EHL had not funded Enerox with an aggregate of EUR3.7 million by 31 December 2021,Cellcube would have had the right to buy back for nominal value such proportion of 39 per cent of the share capital of Enerox as is equivalent to the shortfall in funding.
