What happened to totalenergies & Eni in Lebanon?

Lebanon's first licensing round in 2017 saw a consortium of TotalEnergies, Eni and Russia's Novatek win bids to explore in the offshore 4 and 9 blocks. Novatek pulled out in Sept. 2022, leaving its 20% stake in the hands of the Lebanese government.

Did Eni & totalenergies transfer a 30% interest in Block 4 & 9?

The announcement said agreements would be signed on Sunday.
