Younicos had two primary facilities: Younicos AG in Berlin,Germany,and Younicos Inc. in Austin,Texas. It employed a total of about 130 peopleas of 2017. The company was founded in Berlin,Germany,in 2005 under the name Solon Laboratories by executives of German solar manufacturer Solon.

## Why did Younicos lose £15m in 2016?

Younicos made an operating loss of £15m in 2016 on revenues of £7m. However,the deal makes sense given the growing need for energy storage to help integrate intermittent renewable power,said Bruce Huber,managing partner at Alexa Capital,which advised Younicos on the deal.

Younicos, which has units in Germany and the US, offers modular and scalable smart energy solutions integrating battery storage. Aggreko noted that Younicos's integration and control systems could be deployed across the firm's existing business to lower the cost of energy, ensure reliability and cut carbon dioxide (CO2) emissions.
