Who owns met Asia?

MET Asia, a subsidiary owned 90% by MET Group and 10% by Keppel, will expand MET's business reach to the region, focusing on making the Group's LNG portfolio truly global and expanding its asset base in the Asia-Pacific. MET Group's mission is to become a leading market player by implementing innovation in the European energy markets.

Why is met group a leading energy company in Europe?

MET Group has become one of the fastest growing energy companies in Europe. MET is now present in 13 countries through subsidiaries and 27 national gas markets, with its consolidated revenue increasing from EUR 4.4 billion in 2015 to EUR 18.1 billion in 2021.

Is met group a liquefied natural gas company?

MET Group has one of the most diversified LNG (liquefied natural gas) import structures from a geographical perspective in Europe. What exactly is LNG? As part of its LNG growth strategy, Swiss-based MET Group has reached a partnership agreement with Celsius to build MET's first LNG vessel, scheduled to be delivered in 2027.

What was met group's natural gas trading volume in 2022?

In 2022, MET Group's natural gas trading volume was 109 BCM. MET Group was founded by Benjamin Lakatos in 2007 as an unlisted joint-stock company. MET Group has been present in Zug, Switzerland since 2011. In early 2016, the annual gas trading volume reached 16 BCM (3.8 mi 3).
