Who is an employee in Palau?

f) "Employer" means any individual, partnership, association, or corporation hiring or employing employees in the Republic of Palau and any individual who has in his employ a domestic servant, but does not include any branch or agency of a state government or the national government.

Can an employer impose a wage penalty in Palau?

Employer shall not impose upon employees restrictions, obligations, wage penalties or the like, that are not in the employment contract or that are contrary to the laws of the Republic of Palau. Employer's attempts to do so may subject the Employer to legal action.

What happens if a nonresident worker fails to enter Palau?

If a Nonresident Worker fails to enter the Republic of Palau within sixty days from the 5.5.1 date of issuance of the Provisional Labor Visa or the Work Permit, then the Work Permit shall be void and entry denied.

How do I get a work permit in Palau?

Employers in the private sector seeking to employ Nonresident Workers in the Republic of Palau shall secure Work Permits for such workers by applying to the Bureau of Immigration and Foreign Labor before such workers may enter the Republic of Palau. Certain conditions of employment shall be met by the Employers and by the Nonresident Workers.

What is a temporary work permit in Palau?

v) "Temporary Work Permit" means a ninety (90) day temporary work permit issued to a non-resident who comes to Palau pursuant to 13 PNC § 1022, and which permit shall in no event exceed a total of one hundred eighty (180) days.
