## What is Puerto Rico's battery energy storage system?

The Puerto Rico Electric Power Authority's battery energy storage system is a 20,000kW energy storage project located in Puerto Rico. It was announced in 2018 and will be commissioned in 2020. The Puerto Rico Electric Power Authority owns the system (100%).

How much money does Puerto Rico have to pay for solar?

Up to \$190 millionis available to Puerto Rico's Housing Administration and a private company to pay for solar and battery installations in public housing common areas and subsidized, multifamily housing properties. Another \$175 million is available for certain healthcare and dialysis centers.

How much money is available to install solar & battery storage systems?

SAN JUAN,Puerto Rico (AP) -- The U.S. Department of Energy said Thursday that \$365 millionis available to install solar and battery storage systems in homes and healthcare centers across Puerto Rico.

What is the Puerto Rico energy resilience fund (PR-ERF)?

Funded through the Puerto Rico Energy Resilience Fund (PR-ERF), today's announcement will support DOE's efforts to deploy solar and battery storage systems on up to 40,000 single-family households in Puerto Rico.

Who is developing Puerto Rico's energy grid?

Development is led by Clean Flexible Energy, an indirect subsidiary of AES Corp. and TotalEnergies Holdings USA. A conditional loan guarantee was announced for the project in July. Puerto Rico is aiming to eliminate coal-fired energy generation by 2028 and develop a 100% renewable energy grid by 2050.
