

Zimbabwe erp energy related products

What are energy-related products (ERP) and energy-using products (EuP)?

Energy-related products (ErP) are products that use energy, or that do not use energy but have an indirect impact on energy consumption, such as water using devices, building insulation products, windows, etc. Compared to ErP, energy-using products (EuP) are products which are dependent on energy input (electricity etc.).

What are the energy supply options in Zimbabwe?

Zimbabwe's energy supply options include hydroelectricity, coal, and renewable sources. The grid in Zimbabwe is well developed, with efforts after 1980 extending supplies to rural business and government administrative areas.

Who is responsible for energy issues in Zimbabwe?

The Ministry of Energy and Power Development () is responsible for policy formulation, performance monitoring and regulation of the energy sector in Zimbabwe. They also focus on research, development and promotion of new and renewable sources of energy.

What is the energy supply in Zimbabwe 2021?

In 2021, energy supply in Zimbabwe is a mix of hydropower (70%), coal (29%) and renewable energy sources, according to the Zimbabwe Energy Regulatory Authority. Over the past five years, independent power producers (IPPs) have explored alternative energy sources such as solar, wind, geothermal, biofuels and biomass.

What are Zimbabwe's investment opportunities?

Investment opportunities will arise in two main areas in Zimbabwe in the next decade: renewable energy and petroleum. The government has provided incentives to the energy sector and awarded several IPP licenses to different companies, but very few of these projects have been executed.

Where is electricity produced in Zimbabwe?

Electricity in Zimbabwe is mainly produced at the Kariba Dam Hydroelectric Power Station (about 750 MW) and Hwange Thermal Power Station (920 MW). Additionally, electricity is produced at three minor coal fired stations.
